INFORMATION ABOUT MEMBERSHIP

Following categories of membership are available in YOUNG UTTARAKHAND for individuals / institutions / corporate bodies who are interested or concerned towards development of the People & State of Uttarakhand and preservation of its Cultural & Natural heritage and who subscribe to YOUNG UTTARAKHAND's objectives.

CATEGORY	
Promoter Member	Persons who appended their signatures to the Memorandum of Association adopted in the meeting held on 6th May 2007 and members of the first Governing Body shall be deemed to be promoter members of the society. All promoter members shall pay annual subscription fee of Rs. 200/- or fee as determined by Governing Body from time to time.
Ordinary Member	Any person who pays an annual subscription of Rs. 200/- or fee as determined by General Body from time to time and whose written application is accepted by the two-third majority of the Governing Body shall be ordinary member.
Life Member	Any person who pays a minimum contribution of Rs. 5000/- or fee as determined by General Body from time to time to the society shall be enrolled as a Life Member. Life members shall have all the rights and privileges of an ordinary member.
Institutional Member	Institutions, Trust, Organisations, Work Centers Cooperative or others Societies may become Institutional Members of the Society by paying Rs.5000/- or such annual contribution which may be fixed by the Governing Body from time to time in each case and shall be represented at the General Body of the delegates whose number shall also be fixed by the Governing Body of the society. The institutional members shall have all the rights and privileges of an ordinary member except "To be eligible for election as office bearer of the society".
Honorary Member	Any person who may be eminent scholar, scientist, Artists, Author, Poet, Social Worker, Businessman or Entrepreneur or Specialist in any field may be enrolled as an honorary member of the society and shall have all rights and privileges of any ordinary member except "To be eligible for election as office bearer of the society". The decision in regard to enrollment of any person as honorary member shall be taken by governing body and shall be got ratified in the general body meeting.

General Information:

- For computerization purposes, form must be filled in CAPITAL letters. Incomplete form is liable to be rejected.
 - Membership applications in all categories have to be finally approved by the Governing Body of Young Uttarakhand.
 - As per rules and regulations of Young Uttarakhand, the Governing Body has the right to reject membership application.
 - The decision of the Governing Body shall be final in all matters.
